I. WELCOME

Mr Mike Whan Joint Chairman opened the meeting by welcoming all attendees and presented apologies from Mr Niall Farquharson, Joint Chairman.

2. ROLL CALL

The Chairman confirmed the meeting does satisfy the quorum requirements with 62 National Federation members in attendance. Participants are attending both online and in person. Therefore, the Chairman was able to proceed with this as a valid meeting.

3. APPOINTMENT OF SCRUTINEER

The Chairman announced that IGF Board member, Ms Nicki Hirayama, will be the scrutineer for any votes held during the meeting and then introduced a representative from Lumi who outlined the procedure for electronic voting during the meeting to the membership and performed a test vote.

4. APPROVAL OF MINUTES

The Chairman requested the approval of the Minutes from the 2022 Biennial Meeting held in Paris on 29 August 2022.

The Minutes were approved.

5. FINANCIAL

Mr Scanlon reported that Audited assets totalled USD 5.1m on 31st December 2022 with USD 4.7m cash in the bank and in hand. Income and expenditures were in line with budgeted expectations.

The IGF was able to benefit from favourable interest rates for short term cash deposits and this generated some additional income of USD 32000.

The IGF will continue to implement its delivery model of relying on Delivery Partner resources until 2028, and therefore should have sufficient funds to continue its operations without requiring loan funds from Delivery Partners throughout this period.

Mr Scanlon reported that the Financial Statements for 2022 were audited by Mazars for the first time, and approved by the IGF Board were circulated to the meeting and the membership in the meeting documents. The 2022 financial statements were prepared by Comptabilité Et Gestion SA, an independent accounting firm based in Fribourg, Switzerland and supervised by the IGF Executive Director.

Mr. Busin (Swiss Golf) inquired whether the IGF have invested their money in several different banks? Mr Scanlon confirmed that IGF is working with both the Banque Cantonale Vaudoise and Crédit Suisse. Mr Busin then asked where the IGFs revenues come from? Mr Scanlon stated that the main revenue source is the International Olympic Committee who provides funds for development and following IGFs participation at the Olympic Games. Another income source is from entry fees for the WATC. It was noted that the IGF members do not pay any annual membership or subscription fees to the IGF.



6. REPORTS

a. Administrative Committee Meeting

The Chairman provided an overview of the items covered and discussed the previous day during the Administrative Committee meeting, which included:

2023 WATC Emirates Golf Federation

Mr Robert Fiala, from the Emirates Golf Federation gave a short presentation on the delivery of the Eisenhower Trophy 2023 and the preparations for the Espirito Santo Trophy to the Administrative Committee.

The Committee commended the Federation for their report and the success of the Eisenhower Trophy.

The Chairman gave special mention and thanks to Emirates Golf Federation Vice Chairman General Abdullah Alhashmi present for the great success of the Eisenhower Trophy and for the Emirates Golf Federation amazing hospitality.

2025 World Amateur Team Championships

Mr Joshua Ho, General Manager of the Singapore Golf Association gave a presentation on the planning and preparations for the 2025 World Amateur Team Championships. Mr Ho will also be making a presentation to the meeting.

IGF Administrative Committee Appointments

The meeting was informed that the IGF Administrative Committee approved the reappointment of Ms Claudia Garduño (FMG) - Women's Chairman of the Administrative Committee and Ms Nobuko Hirayama (JGA) as members of the IGF Board until 2025. Their mandate is extended until 2025 as the IGF Biennial Meeting have been changed to odd years. The Chairman thanked Ms Garduño and Ms Hirayama for their tremendous contributions to the IGF Board.

b. 2025 World Amateur Team Championships Host

The Chairman welcomed Mr Joshua Ho, General Manager of the Singapore Golf Association (SGA) and invited him to give a presentation to the meeting on the progress and planning to date for the 2025 World Amateur Team Championships (WATC).

Mr Ho reported that the Championships will be held at the Tanah Merah Country Club in Singapore. Espirito Santo from Ist to 4th October 2025 and Eisenhower Trophy from 8th to IIth October 2025. Climate in Singapore is similar to Abu Dhabi, hot and humid and that rain & tropical thunderstorms could provide challenges during the 2025 WATC.

Tanah Merah Country Club has two golf courses: Garden Course and Tampines Course.

The 2025 WATC will be played on the Tampines Course, which have been renovated in 2019. This course hosted the Singapore Women's Open in 2022 and the International Series Singapore in October 2023.

The SGA is working with the Accor & Shangri-La groups to offer 4 & 5 Stars hotel accommodation that will be located downtown Singapore close to restaurants and tourist attractions and within 30 minutes from the Golf Course and the airport. SGA is also looking for accommodation closer to the course. The booking process and prices will be communicated once the hotels are secured.

To conclude the presentation, a video was played that is available on the IGF Website.

c. IGF Executive Director's report

The Executive Director's report was provided to the membership.



Mr Scanlon introduced the current IGF team made of seven staff located in Lausanne, stating that each of them having a strong Olympic experience. One of the team, Mr Andrew Hofer, is in charge of Olympic Solidarity (OS) and he will reach out to the membership to support them with any O.S. fundings requests.

Paris 2024 Olympic Games

The Paris 2024 mascot and the Golf pictograms for Paris2024 were presented.

A new delivery model has been put in place jointly with the IGF and Paris2024 Organising Committee, with the contract finally being signed on 7 July 2023.

The IGF Head of Agronomy conducted two site visits and homologation review of Le Golf National Golf Course on 19 April 2023 and during the Cazoo Open de France 2023 21-24 September 2023. The IGF is collaborating closely with the team at the Le Golf National to ensure that the condition of the golf course will be of the highest quality for the athletes.

Paris 2024 has reported that it is close to selling out of all of 25,000 tickets for each of the eight sessions.

The IGF has confirmed all its accommodation requirements for Paris 2024. It was noted that a number of NOCs and NFs are still looking for accommodation close to the Golf Course and that the IGF is collaborating closely with the organizing committee to find solutions for the NFs. He also cautioned that the Transportation plan for the event for all populations will be challenging.

A Test Event was conducted in July 2023 during the FFG Junior National Championships where the Omega scoring system was evaluated.

The IGF Communications Committee is led by the PGA Tour communications team and is made up of representatives from each of the delivery partners communications staff. The IGF will soon contact the IGF membership to see how they can assist us before and during the Olympic Games to promote storylines and content for the golf competitions that will display the Olympic spirit.

The Qualification System for Paris 2024 will remain the same as for previous Games editions. Whereby, the IGF will use the official World Golf Rankings to create the Olympic Golf Ranking as a method of determining eligibility.

The top-15 world-ranked players will be eligible for the Olympics, with a limit of four players from a given country. Beyond the top 15, players will be eligible based on the world rankings, with a maximum of two eligible players from each country that does not already have two or more players among the top-15. There will be a total of 60 players for each of the men's and women's competitions. Men's qualifications have started on 13 June 2022 and will close on 17 June 2024, while the Women's qualifications started on 20 June 2022 until 24 June 2024.

At the beginning of 2024, all athletes listed within the Olympic Golf Rankings will enter the IGF anti-doping program and therefore will fall under the jurisdiction of the IGF for anti-doping. The IGF aim to test every player before the Olympic Games and through the International Testing Agency will be working closely with each of the Tours as well as with the National Anti-Doping Authorities. Athletes will be asked to submit their whereabouts per day for anti-doping test.

Dakar 2026 Youth Olympic Games

Currently the IOC is reviewing the programme of those games to determine if all sports can be held in the country.

Mr Scanlon travelled to Dakar on 4 October 2023 with an IOC delegation to assess the golf course condition, whereupon he provided a report to the IOC on the suitability of the golf course for such an event. A meeting with the IOC will be held further to Mr Scanlon's report.



Los Angeles 2028 Olympic Games

During its Session in Mumbai, the IOC membership approved five additional sports to the LA 2028 Olympic Games programme: baseball/softball; cricket; flag football; lacrosse and squash. Golf has already been approved for inclusion in the programme.

There are ongoing discussions between the IGF and LA2028 on the event delivery by the IGF of both the competition and sports services as well as the "outside the ropes" delivery. The competition will be held at the Riviera Country Club where the PGA Genesis Championship is organised, and this is a great opportunity for the IGF to work closely with the organisers of this event.

IOC relations

Mr Scanlon reported that the IGF had regular meetings with the IOC Director of Sport and the Executive Director of the Olympic Games and with other members of the IOC administration. The IGF has attended numerous IOC meetings such as the I4Ist Session in Mumbai, IOC Olympic E sports Series, IOC Safe Sport Forum, IOC IF Medical Commission Chairpersons' meeting, IOC Women in Sport Forum, IOC IF Sustainability Forums and IOC IF Communications Forums. It was also noted that the IOC President reappointed the IGF Executive Director to the IOC Digital & Technology Commission.

Safe Sport

One of the key areas in sport is "Safe sport" and the need for the IGF to protect our athletes health and safety including abuse and harassment. Mr Scanlon urged for each National Federation to train and appoint a Safeguarding Officer within their organisation.

The IGF have appointed a Safeguarding Officer who has undertaken SafeSport training in the US and is currently completing the IOC Safeguarding Officer in Sport Certificate. This person was on site during the WATC and for each event that the IGF is organizing.

It was noted that the IOC has created regional hubs that will function as central coordination points and will provide athletes in these regions with independent guidance, and help them access psychosocial support, legal aid, and any other assistance that they may need.

Mental Health Awareness

The IGF Medical Committee, through Dr Margo Mountjoy, is undertaking evidence-based and research-driven efforts to promote mental well-being across golf which is in line with the IOC Mental Health strategy. A study was conducted last year at the 2022 WATC with the female athletes, focusing on their mental well-being. The outcome of this study has been posted on the IGF Website and some of the findings from the study have been implemented at this WATC.

Another survey, in association with the IOC has also been initiated during this Championships with the results from this survey to be combined with other sports results.

ESports

On June 2023, the IGF participated in the Olympic Esports Series in Singapore. Although not part of the competition format, the IGF played a significant role within the Free to Play Zone, featuring a diverse range of golf-related games, including the PGA Tour 2K console, Full Swing and Trackman simulators, as well as Golf+virtual games.

All the publishers were extremely positive of their experience and expressed their interest in working with the IGF to be a competition sport within the next Olympic esports series. The IGF will work with the IOC Sport department to explore future opportunities for our sport to be part of the ESport Olympics which has been announced last week by the IOC President.

ASOIF & GAISF Relations

Association of Summer Olympic International Federations (ASOIF)



The IGF continues to have a close relationship with ASOIF (Association of Summer Olympic International Federations) and has regular meetings with the President and Chief Executive of the organisation. The IGF Executive Director is also a member of two ASOIF advisory committees.

The IGF attended the ASOIF General Assembly in May 2023 where ASOIF members approved the Paris 2024 Olympic Games International Federation (IF) revenue share scheme which elevated golf to group D, which should result in an increase of income from the IOC for the IGFs contribution to the Paris 2024 Olympic Games in comparison to Tokyo 2020.

General Assembly of International Sport Federations (GAISF)

At its 14 September 2023 Extraordinary General Assembly, GAISF member approved the final steps in the liquidation of the organisation which includes the final balance sheet drawn up by liquidators Ernst & Young, the distribution of the liquidation proceeds to the IF umbrella bodies (ASOIF, AIOWF, ARISF and AIMS), following the principles agreed by the GAISF members in November last year when they voted to dissolve the organisation.

Memberships

The number of memberships has increased since the last Biennial meeting and is now 152. The number of Professional Members remains the same, with 21.

Anti-Doping

It is of upmost importance for the IGF to ensure that its competitions, athletes, and members safeguard the integrity of golf and protect clean athletes through the fight against doping. In support of this, the IGF received notification with WADA that it has met the requirements under the Code Compliance Questionnaire and that it is in compliance with the WADA Code which is critical for our participation in the Olympic Games.

The International Testing Agency (ITA), were present at registration during the ongoing WATC, continues to independently manage the IGF anti-doping programme. They are also aiming at educating our athletes and will work with the IGF Memberships in this regard. It is also important for each National Federation to support the IGF by educating their athletes and make sure they understand and follow the WADA Code.

The IGF have regular meetings with WADA's International Federation Relations and attended the 2023 WADA IF Forum, in Lausanne, Switzerland.

International Paralympic Committee

The Memberships were informed that unfortunately, the application submitted to the International Paralympic Committee last year for golf's inclusion onto the sport programme for the Los Angeles 2028 Paralympic Games, was unsuccessful.

The IGF Board has directed the IGF Administration to look at all opportunities to ensure admission to the Paralympic Programme.

The IGF have appointed the IPC lawyers (Bird& Bird) who writes the IPC Classification Code to develop the IGF code.

The IGF is suspending any Disability World Championship until the classification code is in place.

Commonwealth Games

Last year, golf was admitted to the Commonwealth Games Programme, but in July this year the Victorian government announced the cancellation of the Commonwealth Games due to financial reasons. The IGF has met with the Commonwealth Games Federation (CGF) since this decision and there is no host country identified for the 2026 Commonwealth Games yet.

2029 WATC Bid Process

The Bid Process for the 2029 WATC is currently under review and will be presented to the IGF Administrative Committee for approval. Following this a notice will be sent to the membership for expressions of interest in first quarter of 2025. The host country will be selected at the 2025 WATC Biennial meeting.



Questions arising from the IGF Directors report:

- Mr Morten Bakhausen(Danish Golf Union) asked whether a Team Event is possible at the LA2028 Olympics? Mr Scanlon stated that the IGF is working with the IOC and the Organising Committee to hold a Mixed Team Event during the LA2028 Olympics, and for this to be held between the Men's and Women's Individual Stroke Play Competitions. Logistical aspects still need to be finalized, but this format proposal has generated a lot of enthusiasm.
- Mr Lars Broch Christensen (Danish Golf Union) stated that tickets for the Paris Olympics are sold out and asked what are the chances for NFs to get some tickets for late qualifying teams? Mr Scanlon replied that the IGF will provide four tickets per session for each athlete. Also, for those NOCs that have qualified athletes, one ticket for each session will be given to the President of the National Federation. The last option for NFs to purchase tickets is through the official website of the Organising Committee.
- Online question was received concerning the Qualification System (QS) for the next WATC in 2025 and the number of teams for this event? Mr Scanlon responded that the 2025 QS was discussed the previous day at the Administrative Committee meeting. A full analysis will be done by the IGF Competition Committee following the 2023 WATC with a proposal to be submitted to the IGF Administrative Committee for approval. Due to the limited daylight in Singapore, we do not anticipate an increase in number of teams.
- Online question asking for an update on development of IGF Transgender Policy. Mr Scanlon said that the IGF is working with the LPGA, other professional members and the IGF Medical Committee and will have a policy released next year for events under organized under the IGF jurisdiction and for Professional Womens' Game. Once approved by the IGF Board, it will be circulated to the NFs.

7. 2023 ADMINISTRATIVE COMMITTEE

In accordance with Article 6.9 of the IGF Constitution, the Administrative Committee had proposed at its meeting yesterday that the following National Federations should appoint members of the Administrative Committee.

- Asia-Pacific: Australia, China, India, Japan, and Korea.
- Americas: Argentina, Canada, Chile, and Puerto Rico.
- Europe/Africa Zone: Iceland, the Netherlands, Spain, and South Africa.

A motion was proposed to approve the Administrative Committee's proposed national federations for appointment to the 2024-2025 Administrative Committee.

The motion was approved.



8. ANY OTHER BUSINESS

Chairman opened the floor to questions from the room. There were no questions.

9. CLOSING REMARKS

The Chairman thanked everyone for their attendance and participation in the meeting and the Emirates Golf Federation for hosting the meeting and the 2023 World Amateur Team Championships.

Finance

Financial update

IGF's 2024 accounts were audited by Mazars and the balance sheet, profit and loss statement and notes are attached.

The 2024 financial statements were prepared by Comptabilité Et Gestion SA, an independent accounting firm based in Fribourg and supervised by the IGF Executive Director.

The IGF's reference currency is the US Dollar (USD). Financial statements are converted for presentation purpose into Swiss Francs as of the year end.

Audited assets totalled USD 14,275,396 on 31st December 2024 with USD 12,140,336 cash at bank and in hand.

The IGF received \$16,558,206 as the gross contribution from the IOC for its contribution to the Paris 2024 Olympic Games. This amount reflects a similar amount paid to group D category sports for the Rio 2026 and Tokyo 2020 Olympic Games. Through prudent and tight management of supplier contracts and timeliness of implementation of human resources we were able to successfully bring both the Olympic Games operational project and delivery costs under budget.

Following the receipt of the revenue distribution from the IOC for the Paris 2024 Olympic Games the IGF has invested \$12 million in a monthly short-term investment with our bank BCV. We are in the process of instituting a Finance & Investment Committee that will consider an investment strategy based on the historical cashflows of the IGF through to 2028.

We work with our bank to implement a strategy that limits incurring exposure to the currency fluctuations each month when payments are made to creditors.

We continue to implement the delivery model of a small core team relying on Delivery Partner resources, and where necessary, consultants to deliver specific projects and day -to-day activities. As we have evolved, it has become ever more critical to recognise that achieving delivery of our strategic plan is dependent on our ability to rely upon our delivery partners to fulfil their own commitments.

Provided that the IGF operational model of delivery remains in place through to 2024, the IGF should have sufficient funds to continue its operations without requiring loan funds from our Delivery Partners throughout this period.

The IGF continues to plan and spend responsibly to ensure that we can deliver our projects and operations on time and a balanced budget. IGF's overall financial position remains robust.

As statutory auditor, we have examined the financial statements (balance sheet statement of income and expenditure and notes) of International Golf Federation (IGF) for the financial year ended December 31, 2024.

These financial statements are the responsibility of the Board of Directors. Our responsibility is to perform a limited statutory examination on these financial statements. We confirm that we meet the licensing and independence requirements as stipulated by Swiss law.

We conducted our examination in accordance with the Swiss Standard on the Limited Statutory Examination. This standard requires that we plan and perform a limited statutory examination to identify material misstatements in the financial statements. A limited statutory examination consists primarily of inquiries of company personnel and analytical procedures as well as detailed tests of company documents as considered necessary in the circumstances. However, the testing of operational processes and the internal control system, as well as inquiries and further testing procedures to detect fraud or other legal violations, are not within the scope of this examination.

Based on our limited statutory examination, nothing has come to our attention that causes us to believe that the financial statements and the proposed appropriation of available earnings do not comply with Swiss law and the company's articles of incorporation.

Notes to the financial statements 2024 and 2023 In Swiss Francs with convenience translation into US

1. Activity

The International Golf Federation (IGF) is the world-wide Golf sports organisation, the headquarters of which are located in Lausanne, Switzerland.

The objectives of International Golf Federation are:

- (a) to encourage the international development of the sport of golf;
- (b) to foster friendship and sportmanship among the peoples of the world by organising biennially amateur team championships for the Eisenhower Trophy (for men) and the Espirito Santo trophy (for women);
- (c) to promote golf as an Olympic sport; and
- (d) to act as the international federation for golf in the Olympic Games and thereby to establish and enforce, in accordance with the Olympic spirit, the rules concerning the playing of golf in the Olympic Games and to fulfil in respect of the sport of golf the mission and role of an international federation within the Olympic movement.

2. Summary of significant accounting policies

a. Basis of accounting

IGF uses the accruals basis of accounting in preparing the financial statements.

b. Fixed assets

Fixed assets are stated at acquisition cost. When assets are retired or otherwise disposed of, the cost of the asset and the related accumulated depreciation are removed from the accounts. Any profit or loss on retirement is reflected in the earnings for the period.

c. Depreciation

Depreciation is calculated on the basis of the cost of the assets and on their estimated useful lives using the reducing balance method.

d. Deferred income

Any funds received for events to be held in the future, where reimbursement of these funds would be necessary in the case of event cancellation, are deferred in the balance sheet and not recognised as income until the event for which the funds were received has taken place.

e. Accounting for foreign currencies

The functional currency of IGF is the US Dollar. Assets and liabilities denominated in currencies other than US Dollar are recorded based on exchange rates ruling at the year-end. Transactions denominated in currencies other than US Dollar are recorded at average rates for the year. All exchange losses and realised exchange gains are recognised in the statement of income and expenditure.

Financial statements are converted for presentation purpose into Swiss Francs as of the year end. Assets and liabilities are converted using the exchange rate at the year end whereas elements of the statement of income and expenditure are converted using the average echange rate over the period. The difference arising from the conversion is recognised as conversion gain or loss of the period in the statement of income and expenditure.

Looking ahead, preparations are well underway for the Olympic Games Los Angeles 2028, which will mark the city's



third time hosting. This edition promises an unparalleled celebration of athletic excellence, featuring over 50 Olympic and Paralympic sports. The historic Riviera Country Club in Pacific Palisades will host the golf competitions.

In the wake of the recent fires in Los Angeles, recovery efforts are progressing, and hosting the Games can play a vital role in supporting the region's renewal and economic growth. We are excited to contribute to this effort, especially with the introduction of the new Olympic Golf Mixed-Team Event, recently approved by the International Olympic Committee (IOC). IOC President, the first female and the first
person from Africa to hold this historic role.
I appreciate her pioneering spirit and look

bring to the Olympic Movement.


With the same collaborative spirit, we look forward to the many triumphs ahead. Let us celebrate the remarkable journey of golf and the bright future before us!





IGF EXECUTIVE DIRECTOR'S REPORT

The Executive Director's Report to the IGF's membership covers the activities of the IGF administration since the Biennial Meeting held on 23 October 2023.



The men's and women's individual stroke play golf competitions at the Olympic Games Paris 2024 were a resounding success, showcasing elite talent and thrilling finishes at Le Golf National. In the men's event, Team USA's Scottie Scheffler captured gold with an incredible final round, finishing at 265, just one stroke ahead of Great Britain's Tommy Fleetwood and two ahead of Japan's Hideki Matsuyama. On the women's side, New Zealand's Lydia Ko triumphed, adding Olympic gold to her silver and bronze medals

from the Rio and Tokyo Games, followed by Germany's Esther Henseleit with silver and China's Xiyu Lin with bronze. The competitions were marked by dramatic swings in momentum, passionate fan support and a celebration of golf's growing stature in the Olympic Movement. With top-ranked players fully embracing the Games, Paris 2024 solidified golf's place as a premier Olympic sport.

Olympic Esports Games

The 142nd IOC Session, held in Paris, France, officially endorsed the establishment



of the Olympic Esports Games. The IOC has formed a 12-year partnership with the National Olympic Committee of Saudi Arabia to support the development of the esports initiative and the hosting of the event. In February of this year, the IOC confirmed that the Olympic Esports Games will now take place in 2027 to enhance the event's impact and engagement.

The IGF has submitted two proposals – a console (PGA TOUR 2K25) and a simulator (TMRW Sports) – for potential inclusion in the Olympic Esports Games Programme. The IOC is yet to formally announce the dates or the programme for the inaugural event.




Youth Olympic Games Dakar 2026

The IOC Executive Board met on 13 June 2024 and determined the sports that will be on the programme for the Youth Olympic Games Dakar 2026. Unfortunately, due to several factors unique to hosting these Games in Senegal, the IOC decided that golf was one of ten sports that would not be on the sport programme. The IGF provided several proposals to the IOC to ensure golf remained on the programme, but unfortunately these were not seen as possible to be implemented. The IGF has been assured by the IOC that this decision is unique to the Youth Olympic Games Dakar 2026, and any future editions of these Games will include golf on the sports programme.

Golf for the disabled: Paralympic Games Brisbane 2032 bid

The development of the IGF Classification Code for the Paralympic Games is nearing conclusion, with the remaining aspects pertaining to Sport Class Classification Assessments currently in the final stage.

The new code, once completed, will adhere fully to IPC standards, ensuring we can continue to work on golf's inclusion on the Paralympic programme. The Brisbane 2032



sports application process commenced in July 2025, with submissions due by

December 2025. The final decision on the sports programme is expected in Q4 2026



Protection of the female category in sport

On 23 June 2025, Olympic Day, a ceremony at Olympic House in Lausanne was held to mark the handover of the IOC presidency from Thomas Bach to Kirsty Coventry. Coventry is the first woman and the first African to hold the position. As one of her first initiatives as IOC President, Kirsty Coventry announced the creation of an IOC working group to focus on the protection of the female category. The working group will be made up of experts and International Federations to ensure consensus with all the stakeholders on a policy that would be implemented not only at the Olympic Games Los Angeles 2028 but across all Olympic sports. This is consistent

with the pronouncement during her campaign to review the IOC's Framework on Fairness, Inclusion and Non-Discrimination on the Basis of Gender Identity and Sex Variations and for the IOC to enact a clear and unequivocal policy to protect the integrity of female sport and female athletic competition for implementation by all International Federations. This led to the IGF Board deferring the adoption of an IGF Athlete Inclusion & Competitive Equity Policy until after the IOC working group's findings and recommendations are made.

Safeguarding

The IGF has taken a significant step forward in our commitment to safeguarding our athletes.

In collaboration with UNICEF and The Open University, a golf-specific Safeguarding in Sport e-learning platform has been created. This offers our membership valuable access to three comprehensive online courses aimed at deepening their understanding of safeguarding principles, promoting best practices, and helping them implement effective safeguarding policies for everyone involved in the golf community.

With the availability of this platform the IGF will encourage all our National Federations to appoint a dedicated safeguarding officer to take the lead on local safeguarding efforts. These measures are aimed at solidifying safeguarding as a fundamental responsibility of all National Federations towards all athletes under their care.

IGF Board & Administrative Committee

Finally, I would like to thank the IGF Board and the Administrative Committee for their guidance and support, and to acknowledge the specific contributions to the Board of Martin Slumbers (The R&A), Keith Pelley (ETG), Seth Waugh (PGAA) and Mollie Marcoux Samaan (LPGA), who have resigned since our last Biennial Report and to warmly welcome their successors Mark Darbon, Guy Kinnings, Derek Sprague and Craig Kessler.

In the months prior to the Olympic Games Paris 2024, the Athletes' Committee representatives were presented with a comprehensive overview of the services planned for athletes and caddies at Le Golf National on training and competition days.

This included detailed information on key venue-based athlete services such as food and beverage, medical and physiotherapy support, as well as access to practice areas and gym facilities. Associated schedules and operational plans were also shared for review.

The constructive feedback provided by the Athletes' Committee played a crucial role in refining and enhancing our operational planning for the Olympic Games, ensuring a well-coordinated and athlete-centred delivery of services.

Olympic Solidarity

Over the past two years, the IGF has collaborated closely with various National Federations (NFs) to secure funding through Olympic Solidarity, with the support of their National Olympic Committees (NOCs). Notably, the IGF successfully organised Technical Courses for Coaches in Benin and Zimbabwe in 2023 and 2024 respectively.

Additionally, a significant milestone was achieved as Olympic Solidarity funding was secured by the Slovak Golf Association and the Golf Association of Bosnia and Herzegovina for the Development of National Sports System for golf within their respective countries.

In 2024, two golf coaches received Olympic Solidarity Coaching Scholarships to pursue training in sports science through PAISAC and in physical education in sport at the Sant Cugat High Performance Centre, both of which are partnered with Olympic Solidarity.

At the beginning of 2025, Olympic Solidarity released its programme for the Olympic Games Los Angeles 2028. The IGF will continue to work with our NFs to assist with access to Olympic Solidarity funding through their NOCs.



The IGF has successfully secured funding for the African High-Performance Programme (AHPP) through Olympic Solidarity through to 2028. The programme continues to play a pivotal role in developing golf in Africa. Since its inception in 2022, the AHPP has made substantial strides in elite squad development, conducting continental camps

and implementing "in-country" initiatives. Through collaborative efforts with NFs, the programme has significantly expanded its impact. It not only supports elite athletes but also enhances broader high-performance systems and facilitates coach upskilling across the continent.

The AHPP's evolution from its early achievements in 2022 to its transformative impact by 2024 highlights its ambitious vision. Initiatives such as the inclusion of the aforementioned "in-country" and continental camps have broadened accessibility and engagement across African nations. These camps have not only benefited the AHPP squad but also extended to the selected NF players and coaches, fostering a culture of mutual growth and high performance in their respective countries.

The programme continues to grow, with the focus for 2025-26 being the upskilling of coaches in the selected countries and subsequently across the African continent, along with additional work on high performance pathways in some of the countries included in the programme.

The IGF is currently exploring opportunities for similar development programmes in other regions worldwide.



Olympic Solidarity Scholarship for Athletes - Road to Paris 2024

During the Olympic Solidarity period 2021 to 2024, nine golf athletes received Olympic Solidarity scholarships to aid their preparation for Continental Games and tournaments, with a focus on qualifying for the Olympic Games Paris 2024. We are pleased to report that one of these athletes, Fabrizio Zanotti (Paraguay), successfully qualified for Paris 2024.

These scholarships, coordinated through the NOCs, are aimed at athletes – particularly from smaller delegations - and provide essential support, including access to appropriate local or international training facilities, as well as technical, medical and scientific support, and travel assistance for Olympic Games qualification events.

We encourage all NFs to continue identifying eligible athletes and collaborating with their NOCs to fully utilise this valuable programme. For the Olympic Games Paris 2024, a total of nine scholarships were awarded:

Olympic Games Paris 2024 medical services

Under the supervision and guidance of the IGF Medical Committee, the Paris 2024 Organising Committee successfully implemented a comprehensive range of medical services at the Olympic golf venue. These services were designed to safeguard the health and wellbeing of athletes, spectators and the workforce. This achievement was made possible through meticulous planning and a collaboration among local hospitals, specialised medical units, and on-site medical personnel and first responder teams.

To address on-site health needs, paramedics and medical volunteers were strategically deployed throughout the venue, providing prompt attention to minor injuries and heat exhaustion. Public health initiatives – including hydration stations and health information booths – were established to promote general wellness and enhance the overall health environment.

To ensure an elevated level of care for athletes, the IGF, through our Delivery Partners, appointed two doctors, four physiotherapists and one athletic trainer.

This team of sports medicine specialists offered comprehensive support, such as injury prevention, treatment and rehabilitation services to athletes, in addition to the medical services offered by Paris 2024. On-site physiotherapy and massage services were provided and the IGF procured two ice baths which will remain at Le Golf National as legacy equipment for the French Golf Federation.

2025 WATC medical services

Under the leadership of Dr Patrick Schamasch, the IGF Medical Committee has undertaken diligent planning to ensure the delivery of robust and effective medical services at the 2025 World Amateur Team Championships (WATC). Comprehensive medical spaces, facilities and emergency service providers have been identified, and will be implemented in October 2025.

Given the anticipated high temperatures and humidity levels in Singapore during the WATC, the Committee will oversee the implementation of the IGF's Extreme Heat Guidelines to mitigate heat-related risks and safeguard the health, safety and performance of all participants.

The overall medical services delivered by the IGF team at Paris 2024 are summarised as follows:

IGF anti-doping programme

The IGF remains committed to ensuring the long-term continuity of fair play and integrity in golf through a robust anti-doping programme. In line with this commitment, and to further safeguard the integrity of golf and protect the athletes, the IGF formally delegated its anti-doping programme to the International Testing Agency (ITA) at the beginning of 2022. This strategic partnership will be extended through to 2028.

The anti-doping programme takes a comprehensive and collaborative approach, encompassing rigorous testing protocols, targeted education efforts, and coordination with IGF Delivery Partners as well as international and national anti-doping organisations. In-competition and out-of-competition testing is conducted to ensure athlete compliance with the highest standards of clean sport. Additionally, the programme includes the long-term storage of samples, enabling future reanalysis as testing technologies continue to advance.

Ongoing education and awareness initiatives remain a cornerstone of the programme. Through these combined

measures, the IGF reaffirms its unwavering commitment to upholding the principles of clean sport and protecting the integrity of golf worldwide.

Paris 2024 anti-doping programme

As part of the IGF's comprehensive anti-doping programme for Paris 2024, all athletes were subject to the IGF's testing authority from 26 April to 11 August 2024.

Pre-Games anti-doping education was a key focus, with targeted outreach including dedicated webinars, an online education hub on the IGF website and the publication of the IGF Anti-Doping Handbook for Paris 2024, aimed at both athletes and support personnel.

A total of 141 anti-doping tests were conducted under IGF authority in the lead-up to the Games, resulting in 100% of participating athletes being tested at least once – a benchmark unmatched by any other Olympic sport. An additional six tests were conducted by the ITA during the Games on behalf of the IOC.

There were no filing failures, adverse analytical findings (AAFs) or Anti-Doping

Rule Violations (ADRVs) among tested athletes. In alignment with IOC protocols, a select number of samples have been securely stored for long-term reanalysis, up to a period of 10 years.

The IGF is extremely appreciative of the collaboration and support of the LPGA, PGA TOUR and the PGA European Tour Group for the implementation of the IGF anti-doping programme.

2025 WATC anti-doping programme

The IGF Anti-Doping Committee advised the IGF on its anti-doping programme for the 2025 World Amateur Team Championships, encompassing both testing and education strategies.

As a long-term integrity measure, eight selected samples will be securely stored for up to 10 years, allowing for future reanalysis using evolving detection methods.

A range of anti-doping educational initiatives will be implemented in the lead-up to the Championships, reinforcing our ongoing commitment to fair play and the global fight against doping in sport. ITA Ambassadors will be on-site on registration days to speak with players.





IGF Golfers with Disabilities Committee & IPC relations

The IGF Golfers with Disabilities Committee aims to provide further inclusion and opportunities for people with disabilities to participate in the sport through providing pathways for the growth and development of recreational and competitive golfers with disabilities.

Considerable progress has recently been made on the redrafting of the IGF Classification Code as part of ongoing efforts for golf's future inclusion in the Paralympic Sports Programme. This work, led by the IGF with the support of relevant stakeholders, has been carried out by Bird and Bird Law Firm – who are also responsible for drafting the International Paralympic Committee (IPC) Code – to ensure full alignment with the recently updated IPC Classification Code and the IPC Model Rules.

Alignment of the IPC and IGF codes is a prerequisite for future inclusion on the IPC Sports Programme. With the redrafted IGF code nearing completion, we are actively engaged in ongoing discussions with the IPC to strengthen our relationship and explore the possibility of inclusion in the Paralympic Programme for Brisbane 2032.

While these discussions continue, the IGF's focus will shift towards developing the core elements required for the implementation of the IGF Classification Code. This will include transitioning from a player-driven classification process to one managed by National Federations, as well as finalising Observation Standards, a Golfers with Disabilities Master List and implementing classifier recruitment and retention strategies and protocols for national and international classifiers.



The IGF was represented at several key IPC events, including the Classifier Meeting in November 2024, the IPC International Federation Open Day in May 2025 and

the Membership General Assembly in September 2025. The IGF continues to actively contribute to the IPC's classification surveys and meetings.





Safeguarding

In 2025, the IGF took an important step forward in its commitment to safeguarding by partnering with The R&A, UNICEF (International Safeguards for Children in Sport) and The Open University to integrate golf-specific content into the Safeguarding in Sport e-learning platform.



At the heart of golf are the golfers. Their safety, wellbeing and welfare are crucial to maintaining both the integrity and success of golf worldwide. Guided by this principle, the IGF is pleased to offer our National Federations (NFs) access to the Safeguarding in Sport e-learning platform. This is a series of three comprehensive online courses designed for all members of the sporting community, regardless of role or level of involvement. These courses will help NFs and their members understand safeguarding, plan for the implementation of safeguarding measures and ensure that the correct policies are in place to protect all participants in golf.

These courses aim to:

- Strengthen understanding of safeguarding principles;
- Highlight the importance of safeguarding within all sporting contexts;
- Provide practical strategies for implementing safeguarding measures in golf.

Safeguarding is a shared responsibility. The resources available on the platform are accessible to everyone – athletes, coaches, officials, administrators and volunteers –

reflecting the IGF's commitment to creating a safe and inclusive environment for all participants.

The original e-learning materials were developed by the International Federation of Association Football (FIFA) and have since been adapted to serve a broader audience across multiple sports. This latest enhancement for golf is the result of collaboration among International Federations and sport organisations, ensuring that best practices in safeguarding are shared and applied across disciplines.





Sustainability

The sustainability function within the IGF is responsible for the promotion and education of environmental responsibility and climate action across the organisation and the IGF membership.



The IGF continues to advance our sustainability strategy, with a targeted goal to reduce our carbon footprint by 50% before 2030. From 2025 onwards, the carbon footprint of the World Amateur Team Championships will be measured, including the tracking of key carbon emission indicators. These efforts will further strengthen the IGF's environmental impact reduction strategy, aligning closely with several of the United Nations Sustainable Development Goals.

In January 2025, the IGF entered a four-year partnership with the GEO Foundation for Sustainable Golf. This collaboration aims to promote environmental stewardship and climate action in golf, while simultaneously helping the IGF and its member federations implement sustainability practices. Through this partnership, the GEO Foundation will provide expert guidance, tools and resources to embed sustainability into our operations. This initiative reinforces our commitment as signatory to both the UN Sports for Climate Action Framework and the Sports for Nature initiative.



Sports for Nature

In July 2024, the IGF became one of the first golf signatories of the IUCN Sports for Nature Framework, underscoring our commitment to advancing nature conservation across golf and through sport. In alignment with the framework's four guiding principles, the IGF has developed a practical and collaborative activation plan to ensure meaningful implementation.



From vision to action:

VISION



A thriving global sport that delivers net positive social and environmental impact to the people and landscapes it touches.

MISSION



The IGF will work with all partners and members to help advance golf's sustainability movement – through its own leadership, support for National Federation Members, and helping promote credible progress.

Efforts will be directed to achieving three related goals in sustainability. These relate to the organisation itself; the future of golf; and golf's contribution to wider societal efforts.

1. For the IGF:

ensure the IGF can demonstrate a credible leadership role in sustainable golf, sport and the Olympic movement.

2. For golf:

play a part in improving the environmental stewardship and social value of the sport and enhancing the game's image and reputation.

3. For society:

help deliver a range of positive and tangible direct and indirect impacts for nature, climate and communities.





IOC Relations

The IGF continues to collaborate closely with the International Olympic Committee (IOC), particularly with the IOC Olympic Games Executive Director, IOC Director of Sport and other directors and staff at the IOC on various matters related to the IGF's relationship with the IOC and to the preparation and delivery of the golf competitions at the Olympic Games.

The IOC President reappointed the IGF's Executive Director as a member of the IOC's Technology and Technical Innovation Commission, where he attended meetings on 23 November 2023 and 29 November 2024. The Commission ensures that the IOC has an appropriate strategy for the effective, secure and sustainable exploitation of digital and information technologies in support of the activities of the IOC and the delivery of the Olympic Games and of the Youth Olympic Games.

The Executive Director attended the 141st IOC Session which took place in Mumbai, India, from 15-17 October 2023. The Session

approved the inclusion of modern pentathlon and weightlifting, which were not part of the initial sports programme for the LA 2028 Olympic Programme, and five additional sports; baseball/softball; cricket (T20); flag football; lacrosse (sixes); and squash.

He also attended the 142nd IOC Session, which took place in Paris, France, from 22-24 July 2024, where the Session officially endorsed the IOC Executive Board's proposal to establish the Olympic Esports Games, and the 144th IOC Session in Costa Navarino, Greece, from 19-21 March 2025, where Kirsty Coventry was elected the 10th President of the IOC.









- was a panel member at the IF Forum that took place in Lausanne from 22-23 October 2024. The panel discussed navigating between the pressures on revenue and increasingly complex demands on resources.
- attended the Association of National Olympic Committees (ANOC) general assembly on 29-31 October 2024 at Cascais, Portugal.
- participated in the IOC-LA28 IF Transition Seminar which was held in Lausanne on 20-21 January 2025. The key focus areas



were the finalisation of the event programme and competition schedule, athlete quotas and the venue master plan.

- attended the Olympic Esports Forum held in Lausanne on 1-2 June 2025. The event brought together key stakeholders from the Olympic Movement and the gaming industry to discuss the evolving relationships between traditional sports and esports.
- attended the IOC Presidency hand over ceremony at Olympic House on 23 June 2025, Olympic Day, where Kirsty Coventry succeeded Thomas Bach, who served as IOC President for 12 years and now assumes the role of Honorary President. Coventry, a Zimbabwean and multiple-time Olympic champion swimmer, is the first woman and the first African to hold the position.





ASOIF Relations

The IGF is an active and influential member of the Association of Summer Olympic International Federations (ASOIF), which aims to unite, promote and support all International Summer Olympic Federations, while also representing them on issues of common interest in the Summer Olympic Games and the Olympic Movement.

The IGF Executive Director and ASOIF Director and/or ASOIF President met regularly on assorted items related to the Olympic Games, ASOIF support for its membership and its relationship with the IOC.

The Executive Director:

- chaired the Commercial Advisory Group (CAG) meetings that were held in October 2023, March 2024 and February 2025.
- attended the 48th ASOIF General Assembly in April 2024 and the ASOIF Post Games

Debrief workshop in October 2024, which was also attended by senior representatives from the IOC and Paris 2024.

 attended the ASOIF Sports Development and Education Consultative Group (ASDEG) workshop in November 2024. The workshop was designed to ascertain how ASDEG can best support its member International Federations in development and education by creating a forum of open dialogue between the IFs and the International Council for Coaching Excellence (ICCE) in relation to international coaching standards.



National Federation Members

The IGF member organisations continue to reach golfers around the world.

The IGF recognises 153 National Federation Members from 150 countries around the world. In addition, 21 professional golf organisations have been granted Professional Membership.







Esports and IGF Digital Strategy

The IGF continues to advance its involvement in the evolving digital landscape of sport through active engagement with the International Olympic Committee (IOC) on the development of the Olympic Esports Games.

On 8 July 2024, the IGF and TMRW Sports announced a partnership to use technology to increase global participation, aligning with the IGF's goal to make the sport more accessible. The partnership will capitalise on the Olympic Esports Games, where we will bring together the best golfers in the world to compete in a tech-infused golf event.

The IOC approved the formal establishment of the Olympic Esports Games on 23 July 2024. This came in the wake of the IGF's participation in the 2023 Olympic Esports Series in Singapore and marks a major milestone in the Olympic Movement's digital transformation, reinforcing a shared commitment to innovation, inclusivity and the engagement of new audiences.

To oversee the delivery of this new platform, the IOC has entered into a 12-year hosting agreement with the National Olympic Committee (NOC) of Saudi Arabia. While the inaugural event was initially planned for 2025, the timeline has since been adjusted, with the first edition of the Olympic Esports Games now scheduled for 2027 in Riyadh.

A joint organising committee, comprising the IOC and the Saudi Olympic and Paralympic Committee, has been formed to define the official programme, including game selection, qualification systems, eligibility criteria and safeguarding protocols. Importantly, the Olympic Esports Games will operate independently from the Summer and Winter Games, with its own structure, identity and branding.

In May 2025, the IGF joined other key stakeholders at the IOC Olympic Esports Workshop, where International Federations, NOCs, publishers and event operators came together to shape the future of the Games.

As part of the submission process for discipline proposals, the IGF has put forward two formats that align with Olympic principles and golf's unique strengths:







ESPORTS AND IGF DIGITAL STRATEGY

- 1. PGA TOUR 2K25 a console-based, open-access format with global qualifiers and in-person finals in Saudi Arabia.
- 2. Simulator Experience with TMRW Sports - combining virtual driving and real shortgame play on a 360-degree green, hosted at TGL Stadium in Florida.

Both proposed events support gender inclusion, accessible pathways and

a compelling spectator experience – underscoring golf's adaptability in the digital arena.

The IGF will continue to work closely with the IOC and other stakeholders as the Olympic Esports Games progress towards 2027. Members will be updated regularly as programme details evolve, and qualification pathways are confirmed.



IGF Communications and Content Committee

The IGF Communications and Content Committee supports the communications function as the face and voice of the IGF. Its role is to educate audiences about the sport of golf, highlight the development initiatives already underway and planned for the future, and shine the spotlight on the world of the Olympic Games and the aspirational and inspirational qualities it evokes, for players and fans of the game.

IGF Paris 2024 communication strategy

The IGF communications strategy for the Olympic Games Paris 2024 delivered outstanding results, with strong, coordinated contributions from all Delivery Partners. Under the leadership of the Communications and Content Committee, the strategy elevated event visibility, strengthened stakeholder engagement, and delivered measurable outcomes aligned with the IGF's goal of promoting and positively presenting golf on the global stage.

A collaborative and well-structured approach ensured consistency of messaging, maximised media reach and enhanced golf's image. Key achievements include:

- Website: a redesigned IGF website was successfully launched in April 2024.
- Enhanced visibility: multi-channel campaigns, including social media and press releases, resulted in a substantial increase in IGF audience engagement. Each Delivery Partner leveraged its unique communication strengths to maximise impact.
- Unified messaging: Delivery Partners maintained consistent messaging across

- all platforms, ensuring alignment with the sport's core values, reinforcing stakeholder trust and credibility.
- Increased engagement: interaction levels rose across both traditional and digital platforms. Delivery Partners and several National Federations actively supported the strategy, contributing to strong engagement during Olympic events and related initiatives.
- Effective collaboration: regular planning and coordination sessions among the Communications and Content Committee and Delivery Partners enabled seamless execution. Shared insights, resources and aligned efforts enhanced the overall effectiveness of the campaign.

These efforts have laid a solid foundation for future strategic communications initiatives and demonstrated the importance of collaborative partnerships and unified messaging across all levels of the sport.

Performance highlights:

 Olympic Golf Instagram followers grew by 391% from 1 January 2024, and by over 600% since the formation of the Communications and Content Committee in mid-2022.

 90m impressions, including
 5.9m engagements in 2024.
- 115 of the 120 Olympic golfers (95.8%) used the Greenfly platform, resulting in the global distribution of 13,000 pieces of content.

IGF Digital Asset Management

The IGF recently launched our new Digital Asset Management (DAM) tool which is available to all National Federation Members on a complimentary basis. The DAM system houses our digital photographic collection, and all National Federation Members are granted access to a curated archive of high-quality images from IGF events. This platform is designed to be intuitive and efficient, allowing users to easily search, browse, and download photographs relevant to their editorial needs.

All images available through the DAM system are cleared for editorial use and may be used by members at no cost.

Whether supporting event coverage, preparing internal publications or enhancing communications, this visual resource is intended to support and enrich our members' work.





Olympic Games Paris 2024

The Olympic Games Paris 2024 brought enthusiastic crowds, exceptional performances, and truly memorable golf competitions by our athletes. The enthusiasm and appreciation of these Games are a testament to the hard work and dedication of all those who contributed to the planning and delivery of the competitions.

Paris 2024 sets a new benchmark for Olympic golf

The IGF is proud not only of what was achieved in Paris but also of the manner in which it was delivered. This success is shared across our membership and, in particular, with our Delivery Partners, whose expertise and collaboration enabled the IGF to draw on the very best of our sport. Their professionalism

and commitment resonated with athletes throughout the Games, helping to create an Olympic experience of the highest quality, showcased to millions around the world.

Special recognition is due to the members of the Competition Committee, whose dedication and oversight were central to the planning and operation of the event. Equal thanks go to the agronomy team,



whose skill and professionalism ensured the course conditions met the highest international standards. The exceptional quality of the playing surface was a decisive factor in the success of the golf competitions, reflecting



the outstanding work of the IGF Agronomist together with the Superintendent and his team at Le Golf National.

For Paris 2024, the IGF implemented the IOC's new Event Delivery Model through the establishment of a Competition Delivery Entity (CDE). This structure ensured strong integration within the Paris 2024 Sport Competition Functional Area and allowed the IGF, supported by its Delivery Partners, to guarantee the effective planning and smooth execution of the competitions.

The IGF also values the legacy that remains at Le Golf National as a result of the Games. This includes new tees on the 9th and 17th holes, ice baths and equipment that will remain in place for future use by the French Golf Federation, as well as the invaluable experience gained by the Superintendent and his team in applying the agronomy and maintenance plan. These benefits will endure well beyond the Olympic Games.

The successful delivery of Paris 2024 has established a high standard for Olympic golf. Building on this momentum, the IGF remains committed to further enhancing the experience for athletes and fans alike, and to continuing to strengthen golf's place within the Olympic Movement.





Scheffler and Ko make history

Scottie Scheffler and Lydia Ko claimed gold at Paris 2024, with Scheffler rallying from four shots behind and Ko completing her Olympic medal collection to earn LPGA Hall of Fame induction.







The men's Olympic golf tournament at Le Golf National produced one of the most dramatic finishes of the Olympic Games Paris 2024. With nearly 30,000 spectators each day, the event delivered excitement and intensity at every turn.

The gold medal was decided in spectacular fashion as Scottie Scheffler of the United States came from four shots behind to post a remarkable 9-under 62, setting an Olympic record for 72 holes and finishing at 19-under overall. His round included a string of birdies on the back nine and a decisive putt on the 18th, adding Olympic gold to an astonishing season and reinforcing his position as the world's top-ranked golfer.

Tommy Fleetwood of Great Britain claimed the silver medal with an 18-under total. A Ryder Cup mainstay, Fleetwood's medal was a career highlight and a proud continuation of Great Britain's Olympic golf legacy after Justin Rose's gold in Rio 2016. He mounted a determined challenge throughout the day and briefly tied the lead, but a bogey on the 17th left him one stroke short of gold.

Hideki Matsuyama of Japan earned the bronze medal at 17-under, adding another milestone to his distinguished career and delivering Japan's first men's golf medal since the sport's return to the Olympic programme. The result was especially sweet after he narrowly missed out on the podium in Tokyo, losing in the sevenman playoff for bronze.

Other strong performances included Victor Perez of France, who thrilled home fans with a closing 63 that vaulted him into fourth place, and Jon Rahm of Spain and Rory McIlroy of Ireland, who remained in contention deep into the final round.

Scheffler's victory follows Xander Schauffele's gold medal at Tokyo 2020, giving the United States back-to-back men's Olympic titles. With the excitement of Paris now behind them. players and fans alike turn their attention to Los Angeles 2028, where another world-class contest is anticipated.







In a dramatic and confident display at Le Golf National, Lydia Ko of New Zealand completed her Olympic medal collection with a triumphant gold at the Paris 2024 women's golf competition, securing her place in the LPGA Hall of Fame in one memorable round.

Ko surged ahead early, building a five-shot advantage through a dazzling front nine, only to be set back after a double-bogey on the 13th hole narrowed the margin. She steadied herself with four composed pars down the stretch and calmly buried a clutch birdie on

the 18th green to secure victory at 10-under. two strokes clear of the field.

Germany's Esther Henseleit produced a brilliant final-round 66 to earn silver at 8-under. the first Olympic Games golf medal for her nation. The People's Republic of China's Lin Xiyu captured bronze at 7-under with a solid closing round, becoming the country's second Olympic golf medallist after Shanshan Feng's bronze in Rio 2016.

The week delivered several other standout performances. Bianca Pagdanganan of the Philippines, Australia's Hannah Green, Republic of Korea's Amy Yang and Japan's Miyu Yamashita all tied for fourth at 6-under. demonstrating fierce depth in the field.

French favourite Céline Boutier thrilled home crowds by leading after the opening round, while Colombia's Mariajo Uribe capped her career in fitting style with an eagle on the 18th in her final competitive appearance.

Paris 2024 ultimately showcased drama, poise under pressure, and world-class play from across the globe, with Ko's march to gold standing as the defining moment of a truly memorable competition.

Olympic Games Los Angeles 2028

On 9 April 2025, the International Olympic Committee (IOC) Executive Board approved the addition of a Golf Mixed-Team event to the Olympic programme for Los Angeles 2028 (LA28). This new event will complement the existing individual men's and women's competitions, increasing the total number of golf events at LA28 to three.

The men's event will take place from Wednesday 19 July to Saturday 22 July 2028, one day earlier than previous Olympic Games editions. The women's event will be scheduled from Wednesday 26 July to Saturday 29 July 2028. The competition format will be 72-hole individual stroke play with four rounds scheduled over four consecutive days, with a field of 60 athletes for each of the men's and women's competitions.

The Mixed-Team event will be played between the two individual events, on Sunday 23 and Monday 24 July 2028. The competition will be contested over 36 holes (two rounds) with 16 teams (32 athletes), each team will consist of one male and one female athlete from the same National Olympic Committee who qualified for the individual events. The first round will be played as four-ball (best ball) and the second round as foursomes (alternate shot).

The qualification system for the three events is being finalised and will be submitted to the IOC Executive Board for approval in early 2026.

Riviera Country Club, host of the Genesis Invitational since 1973, will host the Olympic Games golf competitions. Riviera has also hosted other major events such as the U.S. Open, PGA Championship, U.S. Amateur and U.S. Senior Open, and it will host next year's U.S. Women's Open.

Building on the successful implementation of the "Competition Delivery Entity" model at the Olympic Games Paris 2024 – which enabled the IGF to take full accountability for delivering a world-class field of play and a memorable Olympic golf experience for our athletes – the IGF is seeking to expand this approach for LA28.

For the Olympic Games Los Angeles 2028, the IGF's objective is to assume responsibility for the full scope of event delivery, leveraging the experience and operational capacity of the IGF Consortium. In April 2025, the IGF presented an initial scope proposal to the LA28 Organising Committee. A series of workshops have since been initiated and will continue through to the end of 2025, with the aim of reaching a formal agreement.



Olympic Games Brisbane 2032

The Royal Queensland Golf Club is confirmed as the host venue for golf in Brisbane. The Olympic Games will be held from 23 July to 8 August 2032.





World Amateur Team Championships Abu Dhabi, UAE 2023

The 2023 World Amateur Team Championships (WATC) proved a resounding success under the new 36-team format. The Championships were held from 18-28 August at the Abu Dhabi Golf Club, United Arab Emirates.

An extraordinary week of golf saw the dominant USA team take home the Eisenhower Trophy, with Australia and Norway tied for second place. Norway's silver is its first medal in the country's 26 Eisenhower appearances. In the Espirito Santo Trophy, the Republic of Korea topped the podium with Chinese Taipei and Spain taking home the silver and bronze medals respectively. This was Chinese Taipei's first medal in its 16 Espirito Santo appearances.

A total of 42 National Federation Members qualified teams for the 2023 WATC. Six different countries placed on the podium, demonstrating the diverse talent across our National Federation Members.

Eisenhower Trophy - Day 4 recap

The United States of America surged to its 16th Eisenhower Trophy win, and its first since 2014, in the 33rd World Amateur Team Championship at the Abu Dhabi Golf Club. David Ford, the No. 5 ranked amateur in the world, posted an 8-under 64, while

2023 U.S. Amateur champion Nick Dunlap contributed a 4-under 68.

"I just feel so happy for these guys," said USA captain Mark Newell. "This is a great championship filled with lots of good players, and they really earned their victory with great play all four rounds and especially today."

On the strength of a red-hot Ford, who was 6-under through his opening six holes, the Americans quickly established an eight-shot cushion midway through the opening nine. Ford rattled off four consecutive birdies followed by an eagle hole-out from 140 yards on the par-4 sixth to kick-start his final round.

"I've never been 6-under through six before," said Ford, who carded a 29 on the front side. "I didn't look at the leaderboard until about hole 13. I wanted to see where we were and then I just tried to make as many birdies as I could coming in."

Ford's 64 is the second-lowest individual final round score in World Amateur Team Championship history.

After struggling to get things going early on, Dunlap birdied six of his final 10 holes, leading to his 68, and Gordon Sargent, the low amateur in the 2023 U.S. Open, posted a non-counting 71 for the USA in the fourth round. Dunlap (2), Ford (T-5) and Sargent (T-5), who competed together on last month's victorious USA Walker Cup team at St Andrews, all finished in the top five of the individual scoring.

"I love the fact that everybody contributed just about equally," said Newell.





"Every player had the best score at least one day and every player had the highest score at least one day. They all carried the team for stretches and they all ended up shooting about the same scores overall. A true team effort and exactly the kind that it takes to win this kind of event."

The USA's 72-hole score of 36-under-par 540 was 11 strokes better than the silver-medal winning Australia and Norway teams. The 11-shot victory was the largest championship margin since Australia's 19-stroke win in 2016.

Australia used a strong finish by Jack Buchanan (4-under 68), who birdied four of his final five holes, and a counting score from Karl Vilips (2-under 70) to close at 25-under-par 551.

Norway's silver is its first medal in the country's 26 Eisenhower appearances.

The Norwegians, whose previous best finish was fourth place in 2022, used a 3-under 69 from Herman Sekne and a 2-under 70 from Michael Mjaaseth for a team total of 551.

"Obviously, you want to win when you have a chance to, but this is the best that our country has ever finished, so that's something to be proud of," said Sekne, a senior at Purdue University. "Hopefully we'll be back next time and win it."

France finished in fourth place, one stroke behind Australia and Norway at 24-under 552. Italy, the 2022 champions, and New Zealand finished in a tie for fifth place at 553.



Espirito Santo Trophy - Day 4 recap

World No. 4 Minsol Kim's 4-under 68 and a 71 from Kyorim Seo led the Republic of Korea to the gold medal in the 30th World Amateur Team Championship at Abu Dhabi Golf Club. It is Korea's fourth Espirito Santo Trophy victory in the past seven competitions and their fifth overall.

"I'm very honoured that we won this tournament," said Seo. "I'm very grateful for my teammates doing well all four days. Our teamwork and effort helped win today."

Korea jumped out to a solo lead early in the round and never surrendered it. Kim, who was the runner-up in the 2023 Women's Amateur Asia Pacific, made back-to-back birdies on the par-5 second and par-4 third holes and again on the eighth and ninth.

"I was focused on my play," said Kim. "I didn't putt as aggressively as the first three rounds. I was more relaxed and just tried to make par and some became birdies."

Korea's 72-hole score of 22-under-par 554 was four strokes better than silver-medal winning Chinese Taipei and five better than the bronze medal winners Spain.





Chinese Taipei, which began the day three back from the leaders, leaped into silver position after a birdie-birdie finish from Huai-Chien Hsu, a sophomore at the University of Texas. After missing the green left on the par-4 17th, Hsu chipped in from 18 yards for a three and followed with a 9-footer for birdie on the last hole to post a team score of 558.

"I told my coach [on 17], 'I think I can make a birdie here. It doesn't have to be a putt,' and I chipped it in," said Hsu. "I was just trying to birdie a few [holes] on the back [nine] and ended up birdieing four."

This is Chinese Taipei's first medal in its 16 Women's World Amateur Team appearances.

Spain, the 54-hole co-leader, could not find its form of earlier in the week and posted a fourth-round 144, which comprised a 2-under 70 from Cayetana Fernandez Garcia-Poggio and a 74 from Carla Bernat Escuder.

The Spaniards managed to get within two shots of Korea with two holes to play but found heartbreak on the 72nd hole for the second year in a row. All three players bogeyed the par-5 18th hole to drop Spain from silver position to bronze at 559.

"It's really disappointing," said Spain captain Mar Ruiz de la Torre. "Last year we were in the same situation, and this year again. It's really a pity because they played well. We just didn't have too much luck with the putts."

England had a share of the lead with Korea at one point on Saturday afternoon after a batch of birdies from Florida State University teammates Lottie Woad and Charlotte Heath. Woad birdied every par 4 on the front nine to post a 31 at the turn but would cool off on the back nine as England finished with a 4-under

140 to post 560 alongside Thailand, one shot shy of the bronze behind Spain.

Australia and the United States of America finished in a tie for sixth at 561. Megan Schofill led the USA with a bogey-free 5-under 67 and Anna Davis added a 69 as the Americans posted the low-round of the day. Canada was eighth at 564 and New Zealand finished ninth at 565.

Although there is no official recognition, Chinese Taipei's Huai-Chien Hsu was the low individual scorer at 13-under 275.







World Amateur Team Championships Singapore 2025

At its 2023 Biennial Meeting, the IGF National Federation Members elected the Singapore Golf Association (SGA) to host the 31st Espirito Santo Trophy and the 34th Eisenhower Trophy.

The 2025 Championships will be the SGA's first time hosting the WATC after the 2020 edition that they were scheduled to host was cancelled due to the COVID-19 pandemic.

Building on the successful introduction of the 36-team field in 2023, the IGF Administrative Committee approved the use of the same qualification system to determine the final

fields in Singapore. This year, we also revert to the Espirito Santo Trophy being played in week one, followed by the Eisenhower Trophy.

We appreciate the strong partnership with the SGA throughout the planning phase of the 2025 WATC. Site visits in November 2024 and May 2025 highlighted

excellent collaboration between the IGF and the SGA. The IGF thanks the Tanah Merah Country Club for the outstanding conditioning of the course, which will undoubtedly challenge the world's best amateur golfers this October.

We look forward to witnessing two outstanding championship weeks in Singapore.





World Amateur Team Championships Rabat, Morocco 2027

The 2027 World Amateur Team Championships (WATC) will be hosted by the Royal Moroccan Golf Federation at the renowned Royal Dar Es Salam golf course in Rabat, Morocco.

This will be the first time that Morocco hosts the Championships, and only the second time the WATC has been held in Africa.

IGF Financial Report 2023

The 2023 accounts were audited by Mazars LTD, and the balance sheet, income statement and notes are on the following pages. These accounts have been approved by the IGF Board.

Report of the statutory auditor on the limited statutory examination to the Board of Directors of International Golf Federation (IGF), Lausanne.

As statutory auditor, we have examined the financial statements (balance sheet, statement of income and expenditure and notes) of International Golf Federation (IGF) for the financial year ended December 31, 2023.

These financial statements are the responsibility of the Steering Committee. Our responsibility is to perform a limited statutory examination on these financial statements. We confirm that we meet the licensing and independence requirements as stipulated by Swiss law.

We conducted our examination in accordance with the Swiss Standard on the Limited

Statutory Examination. This standard requires that we plan and perform a limited statutory examination to identify material misstatements in the financial statements. A limited statutory examination consists primarily of inquiries of company personnel and analytical procedures as well as detailed tests of company documents as considered necessary in the circumstances. However, the testing of operational processes and the internal control system, as well as inquiries and further testing procedures to detect fraud or other legal violations, are not within the scope of this examination.

Based on our limited statutory examination, nothing has come to our attention that causes us to believe that the financial statements do not comply with Swiss law and the company's articles of incorporation.

1. Activity

The International Golf Federation (IGF) is the world-wide Golf sports organisation, the headquarters of which are located in Lausanne, Switzerland.

The objectives of International Golf Federation are:

- (a) to encourage the international development of the sport of golf;
- (b) to foster friendship and sportmanship among the peoples of the world by organising biennially amateur team championships for the Eisenhower Trophy (for men) and the Espirito Santo trophy (for women);
- (c) to promote golf as an Olympic sport; and
- (d) to act as the international federation for golf in the Olympic Games and thereby to establish and enforce, in accordance with the Olympic spirit, the rules concerning the playing of golf in the Olympic Games and to fulfil in respect of the sport of golf the mission and role of an international federation within the Olympic movement.

2. Summary of significant accounting policies

2.1 Basis of accounting

IGF uses the accruals basis of accounting in preparing the financial statements.

2.2 Fixed assets

Fixed assets are stated at acquisition cost. When assets are retired or otherwise disposed of, the cost of the asset and the related accumulated depreciation are removed from the accounts. Any profit or loss on retirement is reflected in the earnings for the period.

2.3 Depreciation

Depreciation is calculated on the basis of the cost of the assets and on their estimated useful lives using the reducing balance method.

2.4 Deferred income

Any funds received for events to be held in the future, where reimbursement of these funds would be necessary in the case of event cancellation, are deferred in the balance sheet and not recognised as income until the event for which the funds were received has taken place.

2.5 Accounting for foreign currencies

The functional currency of IGF is the US Dollar. Assets and liabilities denominated in currencies other than US Dollar are recorded based on exchange rates ruling at the year-end. Transactions denominated in currencies other than US Dollar are recorded at average rates for the year. All exchange losses and realised exchange gains are recognised in the statement of income and expenditure.

Financial statements are converted for presentation purpose into Swiss Francs as of the year end. Assets and liabilities are converted using the exchange rate at the year end whereas elements of the statement of income and expenditure are converted using the average echange rate over the period. The difference arising from the conversion is recognised as conversion gain or loss of the period in the statement of income and expenditure.

Host of 2029 World Amateur Team Championships

In accordance with the 2029 WATC Event Bidding Rules a Bid Evaluation Panel was convened to oversee the bid process in January 2025. The role of the Panel is to evaluate bids and make recommendations to Biennial Meeting regarding preferred hosts for WATC based on evaluation criteria established by the Bidding Rules.

Following formal communication to National Federation members of the bidding and selection process of the hosts for the 2029 WATC the IGF received three Expression of Interest Letters from the Austrian Golf Association, Bahamas Golf Federation and Egyptian Golf Federation.

The Evaluation Panel then selected the Austrian Golf Association and Bahamas Golf Federation to progress to the Candidate phase and to submit an Application Form.

During the Bid process, the Bahamas Golf Federation withdrew their candidacy and the Austrian Golf Association remained as the sole candidate for the 2029 WATC.

Subsequently, the Austrian Golf Association submitted their Application Form (attached) which was reviewed and evaluated by the Bid Evaluation Panel.

Following this review the Bid Evaluation Panel has made a recommendation (attached) to the IGF membership for the Biennial Meeting to approve the appointment of the Austrian Golf Association as the Host for the 2029 WATC.

The following stipulations apply:

- I. No more than one country can be represented in any one category and the country of the Women's Chair cannot be duplicated.
- 2. The Women's Chair serves a term of six years. She is nominated by the Administrative Committee, and ratified at the Biennial Meeting of the IGF, on a rotating basis among the three zones.
- 3. At least two countries in categories III, IV and V must have a female representative.
- 4. Only one country in category V may be from Africa, but there must be a representative from Africa.
